Dear Potential Exhibitor,

The American Academy of Oral and Maxillofacial Radiology, i.e., AAOMR, is holding its 61<sup>st</sup> Annual Session at the Kona Kai Resort overlooking the San Diego Bay in San Diego California. This year's meeting will be a joint meeting with the American Association of Dental Maxillofacial Radiographic Technicians, i.e., AADMRT.

The AAOMR is the sponsoring and founding organization for **Oral and Maxillofacial Radiology – the ninth formally recognized specialty** of the American Dental Association. The opportunity to exhibit your product to Academy members and radiology specialists will increase your product exposure.

The Academy will have two days scheduled for commercial exhibits. The exhibit space will be in the hotel foyer adjacent the conference rooms where the general meeting sessions will take place. A Booth Requirement Form, a Rules and Regulations Governing Exhibits Form and an Agreement, Release From Liability and Indemnification Form must be downloaded from the website and reviewed by Exhibitors.

All meeting beverage and coffee breaks will be in the exhibit area. Commercial exhibit hours will be from 7:00 AM to 4:45 PM on Thursday, November 18<sup>th</sup> and Friday November 19<sup>th</sup>, 2010. A continental breakfast will be served in the exhibit area on both of these days to encourage early attendance at the exhibits. The Exhibitor's Forum is scheduled for Thursday, November 18<sup>th</sup>, at 3:00 PM. Exhibitors will have the opportunity to introduce their meeting representatives and provide information about their meeting exhibits. This is part of the AAOMR program.

Over 150 registrants are anticipated at the meeting, including oral and maxillofacial radiologists, radiographic technicians, and related dental professionals. The Annual Sessions Committee has worked meticulously to assure the success of this meeting. The number of exhibitor spaces is limited but the hotel is flexible in arranging additional space if needed. The deadline for exhibitor reservations is November 3<sup>rd</sup>, 2010.

A "hard" copy of the signed "Booth Requirements Form" and the signed "Agreement, Release From Liability and Indemnification Form" must be returned by USPS (or other mailing service) directly back to me.
